18. **'Eligible Visa Credit Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional Visa credit cards issued by HSBC.
19. **'Eligible Transactions'** are purchases made with the same Eligible Visa Credit Card at Kai Tak Mall, Kai Tak Arena, Health or Wellness Centre, and Dining Cove with a minimum Net Spending Amount of HK\$50 each for each Eligible Receipt within the same day. These are not Eligible Transactions:
 - a. Any single spending below HK\$50;
 - b. Any spending by cash;
 - c. Any payments using Kai Tak Mall physical or electronic gift vouchers/coupons;
 - d. Any payments using physical or electronic cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or pre-paid cards of merchants within the Venue;
 - e. Purchase of any kinds of membership(s);
 - f. Any purchase of pre-paid items, cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or prepaid cards);
 - g. Any purchase of show/event/concert/exhibition tickets and other ticketing services and any payments of venue or facility booking;
 - h. Adding value to Octopus cards, stored value cards or pre-paid cards;

 - l. Tips towards any spending or purchases;
 - m. Any bill payment (including but not limited to payment of telecommunication or utility bills);
 - n. Any bank transactions; insurance transactions and securities & investment transactions;
 - o. Any spending at travel agencies and property agencies;
 - p. Any activity, programme or course provided or hosted by Friends of KTSP or external third parties (excluding transactions at Kai Tak Mall);
 - q. Any spending of parking or purchase of parking card;
 - r. Any spending in exhibition venues and booths and temporary pop up stores (excluding transactions at Kai Tak Mall);
 - s. EPS cash withdrawal receipts, credit card withdrawal receipts and receipt copies; or
 - t. Any spending at excluded merchants as stated in KTSP Membership Programme Terms and Conditions (which may be updated from time to time without prior notice).
20. **'Eligible Receipts'** include an original machine-printed receipt issued by Designated Merchants at Kai Tak Mall, Kai Tak Arena, Health and Wellness Centre and Dining Cove (where applicable) and a sales slip of your Eligible Visa Credit Card bearing your name where applicable on the date of redemption. Late redemption, handwritten, revised, or copied sales slips and receipts will not be accepted.
21. **'Net Spending Amount'** refers to the final transaction amount charged to the Eligible Visa Credit Card after all applicable discounts, reductions, and use of vouchers.
22. **'Venue'** refers to Kai Tak Mall, Kai Tak Arena, Health and Wellness Centre, and Dining Cove.
23. **'Designated Merchants'** refer to any merchants at Kai Tak Mall, Kai Tak Arena, Health and Wellness Centre, and Dining Cove.
24. **'Offering Merchants'** refer to any merchants at Kai Tak Mall, Kai Tak Arena and Dining Cove with exclusive privileges under Offer 2.
