



Terms and Conditions for Priority Booking for G-DRAGON 2025 WORLD TOUR [Übermensch] IN MACAU (the 'Concert')

When can you enjoy the offer

The Concert is marked seating in relation to the seated zone. No seat selection is available. For purchases of 2 tickets or above, the Designated Platform reserves the right to arrange separate seats/queueing number (including allocation of seats/queueing number in odd numbers and/or non-adjacent seating/queueing number). The ticket purchaser and ticket holder(s) shall accept the seating/queueing number allocation without question. For standing ticket holders, those who arrive later than the designated entrance time announced by the Organiser, will lose their place and taken to the end of the line regardless of the printed queuing number.
