



## Terms and Conditions for Red Hot Shopping Special – Watson’s Wine

### When can you enjoy the offer

1. The promotional period for the offer is from 1 March 2026 to 31 May 2026.

### What is the offer

2. During the promotional period, use your Eligible Credit Card to make transactions at the Participating Merchant to enjoy the following offers:

Single Net Spending Amount	Pay with other Eligible Credit Card and with a Watson’s Wine Club account	Pay with Eligible easy Credit Card or Eligible Visa Platinum Card that is linked to the MoneyBack App and Watson’s Wine Club account
A single transaction of HK\$998 for regular-priced still wine/Sake at stores or eStore	Enjoy HK\$60 off	Enjoy HK\$100 off

8. If we believe that you have acted in a fraudulent or abusive way, you will not be able to enjoy the offers and we can debit your credit card to take back any offers you have enjoyed, or cancel your credit card.
9. The terms and conditions of the Eligible Credit Card will apply.
10. In case of disputes arising out of the promotion, the decision of the Participating Merchant and us shall be final and conclusive.
11. Each of the Bank, the Participating Merchant and you submit to the non-exclusive jurisdiction of the courts of Hong Kong, but these terms and conditions may be enforced in the courts of any competent jurisdiction.
12. These terms and conditions are subject to prevailing regulatory requirements.
13. No person other than you, the Participating Merchant and us which include our successors and assigns will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
14. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ("Hong Kong"). In the event of any discrepancy or inconsistency between the English version and the Chinese version of the promotional materials and these terms and conditions, the English version shall prevail.

#### **What these terms mean**

15. **'Eligible Credit Card'** means any Hong Kong Dollar personal primary, combined additional and separate additional credit cards or UnionPay Dual Currency credit cards (applicable to Hong Kong Dollar sub-account only) issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). For the avoidance of doubt, if the cardholder of the additional credit card is below age 18, he or she is not eligible to enjoy this offer.

16. **'Eligible easy Credit Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional easy Credit Cards (issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns)).
17. **'Eligible Visa Platinum Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional Visa Platinum credit cards (issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns)). HSBC green Credit Card is excluded.
18. **'Participating Merchant'** refers to Watson's Wine Hong Kong stores, eStore and App.
19. **'Net Spending Amount'** means the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions, and use of vouchers.
