



Terms and conditions

1. The offers are only applicable at designated Quality HealthCare Medical Centres during the Program Period.
2. Customers must present their identification document and completed consent form on the vaccination day for verification.
3. Individuals aged below 18 (age as at the date of vaccination) MUST be accompanied by their parent(s)/guardian(s), who will sign on the consent form on behalf of the enrollees in the clinic.
4. SHINGRIX Herpes Zoster / Shingles (Recombinant, adjuvanted) Vaccine: This vaccine item is suitable for individuals aged 50 or above / aged 18 or above at increased risk of herpes zoster. The fee includes doctor's consultation fee of HK\$300.
5. HPV Vaccine (9-in-1) (3 doses): This vaccine item is suitable for individuals aged 15 or above. The fee includes doctor's consultation fee of HK\$300.
6. 15 - Valent Pneumococcal Conjugate Vaccine (VAXNEUVANCE™): This vaccine item is suitable for individuals aged 6 weeks or above. The fee includes doctor's consultation fee of HK\$300 and single dose of 15-Valent Pneumococcal Conjugate Vaccine.
7. 20 - Valent Pneumococcal Conjugate Vaccine (Prevenar 20): This vaccine item is suitable for high-risk individuals aged 18 or above / individuals aged 65 or above. The fee includes doctor's consultation fee of HK\$300.
8. 8Hepatitis A&B (Combined) Vaccine: This vaccine is suitable for people aged 16 or above. To determine the suitability for vaccination, a test report for hepatitis A/B antigen and antibody issued within 3 months of vaccination must be presented prior to vaccination. Extra fee for blood test will be charged if a valid test report is unavailable.
9. Hepatitis B Vaccine: This vaccine is suitable for individuals aged 16 or above. To determine the suitability for vaccination, a test report for hepatitis A/B antigen and antibody issued within 3 months of vaccination must be presented prior to vaccination. Extra fee for blood test will be charged if a valid test report is unavailable.
10. Available while stock lasts.
11. Unless assessed by a doctor and diagnosed as unsuitable for vaccination, once payment is confirmed, the ordered vaccine services cannot be amended or refunded.
12. Applicable only to vaccines where fee includes doctor's consultation fee: Once the doctor's assessment has been performed, the doctor's consultation fee is non-refundable regardless of the result of the suitability for vaccination.
13. Full payment must be settled by eligible credit cards.
