What these terms mean

28. **'Eligible Credit Card'** means an HSBC Premier Mastercard® Credit Card and HSBC Privé issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).
29. **'Eligible Transactions'** are purchases made in Hong Kong Dollars with an Eligible Credit Card (including Apple Pay, Google Pay™ and Samsung Pay) at the Participating Merchant during the promotional period. WeChat Pay, Alipay



and PayMe are not eligible for this promotion. If a transaction is paid by instalments, the Net Spending Amount on the whole transaction (instead of individual instalment payments) will be used to determine the Eligible Transactions.
