

Terms and Conditions for Red Hot Dining Special - Selected Dining Outlets with Stamp Card Reward

When can you enjoy the offer

1. The promotional period for the offer is from 1 October 2023 to 31 December 2023 (unless otherwise specified).

What is the offer

- 2. Offer 1: You can enjoy up to 30% off at designated dining outlets, which are also the participating merchants.
