

Terms and Conditions for HSBC EveryMile Credit Card Exclusive Overseas Spending Offer

When can you enjoy the offer

- 1. The promotional period for the offer is from 1 July to 31 December 2023, and will be divided into 2 phases:
 - a. Phase 1: 1 July to 30 September 2023
 - b. Phase 2: 1 October to 31 December 2023

What is the offer

2. During the promotional period, you can enjoy an extra 1.5% RewardCash rebate when you use an HSBC EveryMile Credit Card (Eligible Credit Card) to make Eligible Overseas Transactions for the first HK\$15,000 eligible overseas spending. You can receive a maximum of an extra \$225 RewardCash in each phase under this offer.

How can you enjoy the offer

- 3. You can enjoy the offer if you:
 - a. hold an Eligible Credit Card and your credit card account is valid and in good standing during the promotional period and the offer fulfilment period;
 - b. have successfully completed the Registration during the promotional period;
 - c. pay with an Eligible Credit Card for any Eligible Transactions during the promotional period.

Read before you enjoy the offer

- 4. You can make a Registration before or after making any relevant transactions. You only need to register once during the promotional period (in any of the phases) and will be entitled to receive the offer from that particular phase upon (i) the completion of Registration and (ii) meeting of the spending requirement. Completion of the Registration does not guarantee the eligibility of a card, transaction(s) or a cardholder for purposes of the offer and the calculation of the extra RewardCash.
- 5. We will calculate the extra RewardCash based on the records we hold on the Registration and the Eligible Transactions. If you qualify for the offer, we will credit the extra RewardCash to your registered Eligible Credit Card account in our record by 31 December 2023 in relation to phase 1; and on or before 31 March 2024 in relation to phase 2.
- 6. The extra RewardCash under this promotion will be awarded in addition to the basic RewardCash under the RewardCash Programme that we offer.
- 7. The total amount of extra RewardCash for each phase under this promotion will be rounded up to the nearest integer.
- 8. If any transaction for which the extra RewardCash was awarded is subsequently reversed, we may deduct the extra RewardCash from the Eligible Credit Card account without notice to you.

- 9. We have no obligation to clarify which transactions are eligible for the offer before you conduct or after you conducted the transactions.
- 10. You cannot exchange the offer for cash, other products, services or discounts or transfer the offer.
- 11. You have to keep all original sales slips or official payment records of the Eligible Transactions. In case of dispute, we may at any time ask you to submit these slips, records, and/or further evidence for inspection and we may keep them.
- 12. The terms and conditions of the Eligible Credit Card, RewardCash Programme and all other applicable prevailing promotions offered by us will apply.
- 13. We can change or cancel the offer or amend the terms and conditions, upon due notice.
- 14. If we believe that you have acted in a fraudulent or abusive way, you will not be able to enjoy the offer and we can deduct the extra RewardCash or debit your credit card to take back any offer you have enjoyed, or cancel your credit card.
- 15. In case of dispute arising out of this promotion, our decision shall be final and conclusive.
- 16. We write the terms and conditions of the offer under Hong Kong laws.

What these terms mean

- 17. **'Eligible Credit Card'** means an HSBC EveryMile Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).
- 18. 'Eligible Transactions' mean any 'Eligible Overseas Transactions' which are eligible for this promotion and conducted with an Eligible Credit Card during the promotional period and posted on our system during the offer fulfilment period. 'Eligible Overseas Transactions' are transactions (i) with original sales slip or official payment record conducted outside Hong Kong according to how such country/region is coded by VISA International; and (ii) in any currency except Hong Kong Dollars. The transaction amount will be based on the currency and amount in Hong Kong Dollars after conversion posted in the credit card statement. These are not Eligible Transactions:
 - Finance and bank charges: annual fees, finance charges, late charges;
 - Other transactions:
 - mail, fax and telephone orders;
 - o transactions settled via HSBC Mobile Banking and/or Internet Banking;
 - purchase and/or reload of stored value cards (including Octopus top-up transactions via e-wallets or any other means);
 - o transaction (including top-up transaction) made via e-wallets;
 - Octopus automatic add-value services transactions;
 - o redemption transactions under 'RewardCash e-shop' and other programmes;
 - any online promotions as may be launched from time to time (as specified by us under such online promotions from time to time to be excluded from this promotion);
 - o cash advance or withdrawal under the Cash Instalment Plan or Cash Credit Plan;
 - o monthly instalment(s) of Cash Instalment Plan, Cash Credit Plan, Spending Instalment Plan or other instalment plans;

- transactions at non-financial institutions (including purchase of foreign currency, money orders and travellers cheques);
- o transactions at financial institutions (including purchase of merchandise and services from banks);
- wire transfers;
- o betting and gambling transactions;
- o tax payments;
- o autopay and recurring transactions;
- o all unposted/cancelled/refunded transactions.
