

Terms and Conditions for HSBC Reward+ Red Hot Stamp Card Reward at TamJai Yunnan Mixian and TamJai SamGor Mixian

## When can you enjoy the offer

1. The promotional period for the offer is from 1 February to 31 December 2024.

## What is the offer

- 2. During the promotional period, use your personal primary card of HSBC Red Credit Card, the Eligible Credit Card, to make Eligible Transactions with single Net Spending Amount of HK\$60 or above at Participating Merchants to earn and collect one stamp via HSBC Reward+ stamp card function. The first 3 stamps collected can instantly redeem an extra \$15 RewardCash via HSBC Reward+ and the next 5 stamps collected can instantly redeem an extra \$20 RewardCash via HSBC Reward+.
- 3. You can earn only 1 stamp per day for spending with Eligible Credit Card at Participating Merchants. You are entitled to earn a maximum of 8 stamps to redeem a maximum of an extra \$35 RewardCash in each phase, and a maximum of 88 stamps to redeem a maximum of an extra \$385 RewardCash during the entire promotional period.

# How can you enjoy the offer

#### What these terms mean

- 17. **'Eligible Credit Card'** means the personal primary card of HSBC Red Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). If you are holding an additional HSBC Red Credit Card, you cannot enjoy the offer.
