



## Terms and Conditions for HSBC Reward+ Red Hot Stamp Card Reward – Paying fares of MTR Rides with Visa Credit Card

### When can you enjoy the offer

1. The promotional period for the offer is from 8 March 2024 to 30 April 2024.

### What is the offer

2. During the promotional period, use your personal primary card of HSBC Visa Credit Card, the Eligible Credit Card, to make Eligible Transactions with Daily Net Spending Amount of HK\$5 or above at the Participating Merchants to earn and collect one stamp via HSBC Reward+ stamp card function. Every 5 stamps collected can be instantly redeemed for an extra \$10 RewardCash via HSBC Reward+.

3. Each cardholder can earn only 1 stamp per day by spending with Eligible Credit Card at Participating Merchants. You are entitled to earn a maximum of 20 stamps to redeem a maximum of an extra \$40 RewardCash during the entire promotional period.

4. Stamps earned can only be redeemed within the promotional period with a grace period of 20 calendar days (see table below). In the event that the stamps are not redeemed by the end of the 20-day grace period, the stamps will become invalid.

- b. have downloaded HSBC Reward+ and have registered for HSBC Personal Internet Banking;
- c. have successfully completed the Registration via HSBC Reward+ during the promotional period; and
- d. pay with an Eligible Credit Card for any Eligible Transaction at the Participating Merchants during the promotional period.

### **Read before you enjoy the offer**

6. You must make a Registration on or before the same day of making any relevant transactions, any Eligible Transactions made before the day of Registration will not be counted. The redeemed extra RewardCash will be credited to the first register credit card account; change to other credit card account is not acceptable after registration.
8. You cannot exchange the offer for cash, other products, services or discounts or transfer the offer.
9. You have to keep all original sales slips of the Eligible Transactions. Eligible Credit Card numbers must be clearly shown in the original sales slips. In case of dispute, we may at any time ask you to submit these slips, and/or further documents or evidence for inspection and we may keep them.
10. If any transaction where the extra RewardCash was awarded is subsequently reversed, we may deduct the extra RewardCash from the Eligible Credit Card account without notice to you.

We accept no liability in respect of the quality of the goods and services provided by the Participating Merchants or any additional offers/discounts which the Participating Merchants may or may not offer. You are advised to check the details and related terms and conditions with the staff of the Participating Merchants.
12. These terms and conditions and other terms and conditions of the Eligible Credit Card, the RewardCash Programme, HSBC Reward+ and the Participating Merchants will apply. We and the Participating Merchants reserve the right to vary or cancel the offer, or amend the terms and conditions. 13. If we or the Participating Merchant believe that you have acted in a fraudulent or abusive way, you will not be able to enjoy the offers and we can debit your credit card to take back any offers you have enjoyed, or cancel your credit card.
14. In case of disputes arising out of this promotion, the decision of the Participating Merchants and us shall be final and conclusive.

15. We write the terms and conditions of the offer under Hong Kong laws. In the event of any discrepancy or inconsistency between the English version and the Chinese version of the promotional materials and these terms and conditions, the English version shall prevail.

**What these terms mean**

16. **'Participating Merchants'** mean MTR Corporation Limited.

17. **'Eligible Credit Card'** means the personal primary card of HSBC Visa Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). If you are holding an additional HSBC Visa Credit Card, you cannot enjoy the offer.

18. **'Eligible Transactions'** are purchases made in Hong Kong dollars with an Eligible Credit Card with a minimum Net Spending Amount of HK\$5 each day at the Participating Merchants during the promotional period and posted on our system during the offer fulfilment period. These are not Eligible Transactions:

- transactions (including top-up transactions) made via e-wallets
- all unposted/cancelled/refunded transactions
- transactions made at the Customer Service Centres in MTR stations for purchasing Multi Rides Tickets or any other product

19. **'Net Spending Amount'** means the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions and use of vouchers/gift cards.

20. **'HSBC Reward+'** refers to the HSBC HK Reward+ mobile application.

21. **'Registration'** means the successful registration of an Eligible Credit Card via the HSBC HK Reward+ mobile application.
