

Terms and Conditions of Red Hot Shopping Special – MTR Malls

When can you enjoy the offers

1. The promotional period for the offer is from 1 April 2024 to 30 June 2024.

What are the offers

2. **Offer 1:** Use your Eligible Credit Card to make Eligible Transactions upon reaching the designated cumulative same-day Net Spending Amounts in the same Participating Malls to receive:

How can you enjoy the offers

 - a. hold an Eligible Credit Card and your credit card account is valid and in good standing during the promotional period;
 - b. have successfully registered as a MTR Mobile registered user;
 - c. pay with an Eligible Credit Card for any Eligible Transactions at the Participating Malls during the promotional period and

d. register at the Self-redemption Kiosk at the same Participating Malls within seven days from the date of the Eligible Transaction made (as per the date stated on the machine-printed receipts) on or before 30 June 2024.

Read before you enjoy the offer

- 4. You must download the latest version of MTR Mobile and register as a MTR Mobile registered user to enjoy the offer. Each cardholder can only register as a MTR Mobile registered user with their mobile number or email address for once only. Duplicate registration of the same mobile number or holding more than one membership accounts by the same individual or by any means to hack and/or amend computer software to redeem MTR Points or eCoupon to spend at shop will not be accepted absolutely. Latest mobile version and operating system are required, otherwise, users may not be able to use eCoupon.
- 5. Primary Cardholders and additional Cardholders under the same Eligible Credit Card account shall for all purposes of this promotion be treated as separate Cardholders and are each eligible to enjoy the offers using the Eligible Credit Cards under their respective names. Primary Cardholders and additional Cardholders under the same Eligible Credit Card account can separately redeem Offer 1 per reward & Offer 2 up to 6 times each during the entire promotional period.

11. Each Eligible Credit Card sales slip and merchant sales receipt can be used to register for the rewards under Offer 1 once only. For verification purpose, staff at the Self-redemption Counter at Participating Malls or management office reserves the right to request you to present your proof of identity, record the first 6 or last 4 digits of your Eligible Credit Card and capture the images of machine-printed receipt(s) from outlet(s) and corresponding electronic payment slip(s)/ transaction record(s) in logged-in mobile payment App for verification, MTR Malls may not process the redemption if you refuse to provide the relevant information.
- 14. Related images collected are retained for the above purposes only and will be destroyed within three months upon the completion of the promotional period.
- 15. For the MTR Points earned on transaction date between 1 April and 30 April 2024, the expiry date would be 3 May, 2024.
- 16. Upon rewards redemption, cardholders should check the eCoupon and the total amount of updated MTR Points at the time of redemption. Once the MTR Points and the eCoupon redemption procedure is completed, MTR Points and the eCoupon will not be returned or changed. - 23. If we, the Participating Malls and the Participating Dining Outlets believe that you have acted in a fraudulent or abusive manner, you will not be able to enjoy the offer.
- 24. You understand and acknowledge that we are not the supplier of the products / services / offers / food / beverages purchased and accept no liability for their quality.
- 25. In case of disputes arising out of this promotion, the decision of Participating Malls or us shall be final and conclusive.
- 26. We write the terms and conditions of the offer under Hong Kong laws. In the event of any discrepancy or inconsistency between the English version and the Chinese version of the promotional materials and these terms and conditions, the English version shall prevail.

What these terms mean

- 27. **"Eligible Credit Card"** refers to any Hong Kong Dollar primary, combined additional, separate additional credit cards or UnionPay Dual Currency credit cards (applicable to Hong Kong Dollar sub-account only) issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).
- 28. **"Eligible Transactions"** are purchases made with the same Eligible Credit Card in Hong Kong Dollars at Participating Malls within the same day at the same mall (including Apple Pay, Google Pay, Samsung Pay and QR code payment via HSBC Reward+). The spending amount of each receipt must be at least HK\$200. Split transactions are not accepted. For instalment payment, only the first month's instalment payment amount will be accepted, and the remaining balance cannot be used to participate in any other promotional activities. Eligible Transactions do not include the following:
 - Transactions made by WeChat Pay, Alipay, PayMe, and OpenRice Pay;
 - Receipts from the following shops or services or transactions are also not entitled to earn MTR Points:

- Any non-designated electronic payment, temporary promotional booths, online shopping / takeaway order platform (including online shopping transaction which is paid at the physical shop), online ticketing (excluding online purchase of movie tickets from Emperor Cinemas), online payment (including collect in store) or transfer, purchase and usage of cash coupons / gift vouchers / coupons / gift cards / stored value cards or cards of similar nature (Note: including without limitation the cost and non-refundable deposits of the concerned vouchers / coupons / gift cards / stored value cards which are all not entitled to earn MTR Points. Regardless of whether the concerned vouchers / coupons / gift cards and stored value cards are with or without pre-loaded value, they are not entitled to earn MTR Points), reload of stored value cards (except game centre), bill payments, autopay, bank, foreign currency exchanges, insurance and value-added services, property rental and sale, domestic services, other non-retail related spending (for instance: care and maintenance services, repair services, goods delivery, dismantling services, installation services), betting, school fees, purchase of travel or transport or entertainment related tickets fees or charges, 999.9 gold and gold savings club (not including decorated gold).
- 29. **"Net Spending Amount"** refers to the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions and value of Cash Vouchers (if applicable).
- "Participating Malls" refer to the designated malls of MTR Corporation Limited, including Telford Plaza, Maritime Square, PopCorn, The LOHAS, The Wai and Luk Yeung Galleria.
- 31. "**Designated Merchants**" refer to any participating merchants at the Participating Malls with shopping privileges under Offer 3.
- 32. "**Participating Dining Outlets**" refer to the participating dining outlets at the Participating Malls. Please refer to the MTR Malls website for the updated shop categories.
