



Terms and Conditions for Red Hot Shopping Special – Watson’s Wine

When can you enjoy the offers

What are the offers

2. During the promotional period, use your Eligible Credit Card to make transactions at the Participating Merchant to enjoy:

What this term means

12. **'Eligible Credit Card'** means any Hong Kong Dollar personal primary, combined additional and separate additional credit cards or UnionPay Dual Currency credit cards (applicable to Hong Kong Dollar sub-account only) issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). For the avoidance of doubt, if the cardholder of the additional credit card is below age 18, he or she is not eligible to enjoy this offer.
13. **'Eligible easy Credit Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional easy Credit Cards (issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).
14. **'Eligible Visa Platinum Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional Visa Platinum credit cards (issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). HSBC green Credit Card is excluded.
15. **'Participating Merchant'** refers to Watson's Wine Hong Kong stores, eStore and App.
