

Terms and Conditions for HSBC Reward+ Red Hot Stamp Card Reward – AS Watson Selected Merchants

When can you enjoy the offer

1. The promotional period for the offer is from 1 May 2025 to 31 July 2025.

What is the offer

2. Each Eligible Transaction made with an Eligible Credit Card during the promotional period will be entitled to earn one stamp via HSBC Reward+ stamp card function. Eligible Cardholders are entitled to earn a maximum of eight (8) stamps to redeem a maximum of an extra \$100 RewardCash for the entire promotional period on HSBC Reward+. Details as follows:

3	\$30
5	\$30
8	\$40

You can instantly redeem your stamps for the extra RewardCash once you accumulate the designated number of stamps.

- **3.** A maximum of two stamps per each Participating Merchant will be awarded for the respective Eligible Transaction for the entire promotional period. Eligible Cardholders can earn one stamp per day for each of the Participating Merchant, and a maximum of six stamps per day among the Participating Merchants.
- 4. Stamps earned during the promotional period can only be redeemed on or before 20 August 2025, i.e. within a grace period of 20 calendar days after the end of promotion. In the event that the stamps are not redeemed by the end of the 20-day grace period, the stamps will become invalid.

- **9.** The stamp earned will be reflected on HSBC Reward+ stamp card detail page within 3 working days after the Eligible Transaction has been posted.

We accept no liability in respect of the quality of the goods and services provided by the Participating Merchants or any additional offers/discounts which the Participating Merchants may or may not offer. You are advised to check the details and related terms and conditions with the staff of the Participating Merchants.
- 14. These terms and conditions and other terms and conditions of the Eligible Credit Card, the RewardCash Programme, HSBC Reward+ and the Participating Merchants will apply. We and the Participating Merchants reserve the right to vary or cancel the offer or amend the terms and conditions. Please refer to the relevant website for the latest details, availability and terms and conditions of the offer.
- **15.** If we or the Participating Merchants believe that you have acted in a fraudulent or abusive way, you will not be able to enjoy the offers and we can debit your credit card to take back any offers you have enjoyed or cancel your credit card.
- **16.** In case of disputes arising out of this promotion, the decision of the Participating Merchants and us shall be final and conclusive.
- 17. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ('Hong Kong'). In the event of any discrepancy or inconsistency between the English version and the Chinese version of the promotional materials and these terms and conditions, the English version shall prevail.

What these terms mean

- 19. 'Eligible Credit Card' means a Hong Kong Dollar personal primary, combined additional and separate additional easy Credit Card and Visa Platinum Card (excluding HSBC green Card) issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns).
- 20. 'Eligible Cardholder' means cardholders who are holding a Hong Kong Dollar personal primary, combined additional and separate additional easy Credit Card or Visa

Platinum Card (excluding HSBC Green Card) issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). If you only hold additional easy Credit Card or Visa Platinum Card, you cannot make a Registration and are not eligible for the offer.

21. 'Participating Merchants' mean:

- 22. **'Net Spending Amount'** means the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions, and use of vouchers/gift cards.
- 23. **'HSBC Reward+'** refers to the HSBC HK Reward+ mobile application.
- 24. **'Registration'** means the successful registration of an Eligible Credit Card via the HSBC HK Reward+ mobile application.
