

Terms and Conditions for HSBC EveryMile Credit Card Amigo Ride Offer

When can you enjoy the offer

1. The promotional period for the offer is from 1 August 2025 to 31 January 2026.

What is the offer

2. During the promotional period, you can enjoy a 3% spending rebate on surcharge when you use an HSBC EveryMile Credit Card (Eligible Credit Card) to make Eligible Transactions at the Designated Merchant with a Net Spending Amount of HKD80 or above via a taxi-hailing mobile application, or through the in-taxi POS terminal. You can receive a maximum of HKD5 spending rebate for each trip and a maximum of HKD150 spending rebate for the entire promotional period.

How can you enjoy the offer

- 3. You can enjoy the offer if you:
 - a. hold an Eligible Credit Card and your credit card account is valid and in good standing during the promotional period and the offer fulfilment period;
 - b. pay with an Eligible Credit Card for any Eligible Transactions at the Designated Merchant during the promotional period.

Read before you enjoy the offer

- 4. You cannot:
 - a. exchange the offer for cash, other products, services or discounts or transfer the offer; and
 - b. unless otherwise specified, use the offer in conjunction with any other discounts or promotional offers.
- 5. We will calculate the spending rebate based on the records we hold on the Eligible Transactions. If you qualify for the offer, we will credit the spending rebate to your Eligible Credit Card account by 30 April 2026.

- 6. The total amount of spending rebate for the entire promotional period will be rounded up to the nearest integer.
- 7. If any transaction where the spending rebate was awarded is subsequently reversed, we may deduct the spending rebate from the Eligible Credit Card account without notice to you.
- 8. You have to keep all original sales slips or official payment records of the Eligible Transactions. In case of dispute, we may at any time ask you to submit these slips, official payment records and/or further evidence for inspection and we may keep them.
- 9. The terms and conditions of the Eligible Credit Card will apply.
- 10. The offer under this promotion is subject to these terms and conditions and other terms and conditions stipulated by the Designated Merchant. We and the Designated Merchant can change or cancel the offers or amend the terms and conditions. Please check the relevant website or communication materials for the latest details, availability and terms and conditions of the offer.
- 11. If we believe that you have acted in a fraudulent or abusive way, you will not be able to enjoy the offer and we can deduct the spending rebate, or debit your credit card to take back any offer you have enjoyed, or cancel your credit card.
- 12. In case of disputes arising out of this promotion, the decision of the Designated Merchant and us shall be final and conclusive.
- 13. No person other than you and us which include our successors and assigns will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
- 14. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ('Hong Kong'). In the event of any discrepancy or inconsistency between the English version and the Chinese version of the promotional materials and these terms and conditions, the English version shall prevail.

What these terms mean

15. 'Designated Merchant' means any taxis of Amigo in Hong Kong.

16. 'Eligible Credit Card' refers to HSBC EveryMile Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and

assigns).

17. 'Eligible Transactions' are transactions made in Hong Kong dollars with an Eligible Credit Card with a minimum Net Spending Amount of HKD80 each at the Designated

Merchant during the promotional period and posted on our system during the offer fulfilment period. All transactions (including top-up transactions) made via e-wallets and

unposted/cancelled/refunded transactions will not qualify as Eligible Transactions for

this promotion.

18. 'Net Spending Amount' means the final transaction amount charged to the Eligible

Credit Card after all applicable discounts, reductions and use of vouchers/gift cards.
